Juror – J. Bruce Schwabach taught for over thirty-five years as an Associate Professor of Fine Arts at Herkimer County Community College. A life-long devotion to art began with childhood trips to MOMA in NYC and progressed to travels throughout the US, and to France, England and Italy. He has found inspiration in the work of Bonnard, Turner, Van Gogh, Renoir and Monet. His accomplishments include creating sixty pastels and thirty oils of sites on the Erie Canal. Bruce maintains a studio in Little Falls, NY where he does what he has loved his entire life; work as a full-time artist.

Eligibility – Artists living in New York State may enter.

Media – Entries may be in any media. Maximum height or width for 2D work is 50 inches, 3D pieces cannot exceed 24 inches in any dimension.

- Two **Juror’s Choice Awards** of \$100 each

Delivery and Retrieval of Works – Attach a copy of your entry form to the back of accepted pieces. Artwork must be ready to exhibit; no sawtooth hangers. The Arkell Museum and Canajoharie Library does not insure accepted work. Artwork must be picked-up between January 5th and 7th by artist or authorized representative. Works may not be removed prior to end of show.

Sales – All works in the show are for sale unless marked NFS by artist. Museum and Library assumes a 30% commission.

To apply:

Email **one** high resolution (300 dpi) .jpg or .tif of each 2-D work to be considered, or two image files for each 3-D piece. Label each file **Title_LastName.jpg**. Email images (under 3 mg, total) to mbvought@arkellmuseum.org. Include **“Juried Art Show”** in the subject line and your name and title of the piece in the body of the email. This prospectus can be downloaded from the payment link below, filled out electronically, and emailed with your images. Keep a copy for your records.
