Juror – Ann Larsen is an award winning artist living in upstate New York's Adirondack Mountains. After completing a BA from the University of Central Oklahoma, she moved to Denver, CO, where she began to focus on her painting and fell in love with the western landscape. She currently spends time painting the Adirondacks, the coast of Maine and throughout the Southwest. Ann is a Master Signature Member of American Women Artists and Past President, among many other professional artist affiliations. In 2016 she was awarded Outstanding Landscape at the American Women Artists National Members & Juried Show in Bennington, VT, Award of Excellence by Oil Painters of America, Eastern Regional in Cincinnati, OH, and Award of Merit by Outdoor Painters Society in Dallas, TX. She has taught workshops and exhibited throughout the US.

Eligibility – Artists living in New York State may enter.

Media – Entries may be in any media. Maximum height or width for 2D work is 50 inches, 3D pieces cannot exceed 24 inches in any dimension.

Awards

- Best in Show: \$300 cash prize and solo exhibit in one of the Regional Art Galleries.
- Two Juror's Choice Awards of \$100 cash plus a \$100 gift card. Sponsored by Golden Artist Colors and Blick Art Materials.
- Awards of Excellence – Two awards of \$100 gift cards. Sponsored by Blick Art Materials

Delivery and Retrieval of Works – Attach a copy of your entry form to the back of accepted pieces. Artwork must be hand-delivered and ready to exhibit; no sawtooth hangers. The Arkell Museum and Canajoharie Library does not insure accepted work. Artwork must be picked-up between January 4th and 6th by the artist or authorized representative. Works may not be removed prior to end of show.

Sales – All works in the show are for sale unless marked NFS by artist. Museum and Library assumes a 30% commission.

To apply – Email one high resolution (300 dpi) .jpg or .tif of each 2-D work to be considered, or two image files for each 3-D piece. Label each file Title.jpg. Email images (under 3 mg, total) to mbvought@arkellmuseum.org. Include "Juried Art Show" in the subject line and your name and title of the piece in the body of the email. Download this prospectus from the payment link below, fill out electronically, and email with your images. Incomplete applications will not be accepted. Keep a copy for your records.
